Basic members

"Basic" members are pension plan members who do not receive Social Security benefits, including public safety employees and other employees hired before the retirement plan coordinated with Social Security (*generally before 1980*).

Basic member statutory references

- Chapter 3A** Legislators first elected before July 1, 1997 and who have not elected to transfer to the Unclassified Plan.
- Chapter 352B** State law enforcement personnel. This includes peace officers under Section 626.84 working for:
- ❖ the State Patrol;
 - ❖ the Bureau of Criminal Apprehension;
 - ❖ a Fugitive Apprehension Unit at the Dept. of Corrections;
 - ❖ Commerce Fraud Bureau; and
 - ❖ the Dept. of Natural Resources as a conservation officer.

- Chapter 353** PERA General Plan – A small number of local government employees in non-public-safety roles first hired before 1968.
See Minn. Stat. § 353.01, Subd. 2a.
- PERA Police and Fire Plan – Local government law enforcement personnel who are peace officers under §§ 656.84 to 626.863 and full time firefighters engaged in the hazards of firefighting. This includes:
- ❖ municipal police officers including supervisory ranks up to Chief;
 - ❖ county sheriff’s deputies;
 - ❖ University of Minnesota, Metro Transit, and Metropolitan Airports Commission police officers;
 - ❖ certain employees of the Minnesota Sheriffs’ Association;
 - ❖ some tribal police;
 - ❖ paramedics and EMTs and their supervisors employed by Hennepin Healthcare System, Inc.; and
 - ❖ certain Department of Military Affairs firefighters.

- Chapter 354** A small number of teachers first hired before 1957. Teachers include:
- ❖ licensed teachers;
 - ❖ supervisors, principals, and superintendents;
 - ❖ librarians, nurses, counselors, social workers, therapists, or psychologists working in a school; and
 - ❖ certain employees and faculty of the Minnesota Colleges and University system

- Chapter 354A** A small number of teachers and administrators employed by the Saint Paul School District first hired before 1978
