1.17	Subd. 11a. Offset amount. "Offset amount" means the lesser of \$10,000 or 25 percent

3.14	was unaware of the right to elect such a transfer;
3.15	(2) the date on which the person first became a participant in the individual retirement

3.17	(3) a signed release authorizing Minnesota State to provide employment and other
3.18	personnel information to the Teachers Retirement Association; and
3.19	(4) any other information that Minnesota State may require.
3.20	(b) No later than 60 days after receipt of the application under paragraph (a), Minnesota
3.21	State must verify the information provided by the person in the application, determine
3.22	whether the person is an eligible person under subdivision 3, and provide a written response
3.23	to the person regarding the determination of eligibility. If Minnesota State determines that
3.24	the person is not an eligible person, Minnesota State must include a copy of any
3.25	documentation identified in subdivision 3, paragraph (b), in its written response to the

Service credit for vesting. The Teachers Retirement Association must grant 6.8 service credit to the eligible person for all years or partial years of service with Minnesota 6.9 6.10 State for the purpose of vesting in a retirement annuity under section 354.44 or in a retirement benefit under section 354.46 or 354.48. 6.11 Subd. 9. Notice to employees. No later than March 31, 2025, and periodically thereafter, 6.12 Minnesota State must provide notice to all employees summarizing this section and offer 6.13 assistance to any eligible person who wishes to elect to transfer coverage from the individual 6.14 retirement account plan to the Teachers Retirement Association. Minnesota State must 6.15 designate personnel responsible for assisting employees with the requirements of this section. 6.16 The notice must identify these personnel and provide their contact information. 6.17 Subd. 10. Annual report required. The chancellor and the executive director must 6.18 submit an annual report to the Legislative Commission on Pensions and Retirement stating 6.19 the number of employees who elected a transfer during the prior calendar year. Without 6.20 identifying any eligible person, the report must include, for each eligible person, the cost 6.21 of the transfer to the eligible persons and Minnesota State, the offset amount, if any, and, 6.22 if applicable, the actuarial cost of the eligible person's pension benefit at the time of the 6.23 transfer as calculated by the Teachers Retirement Association.
