

## 60/35 Reasonable Retirement

## Probation and Parole Staff Petition

Minnesota Legislative Commission on Pensions and Retirement 4/22/2025

"SF1986/HF1779 proposed bill is currently before the Legislative Commission on Pensions and Retirement. This bill reduces the retirement age for probation and parole staff across the state of Minnesota from age 66 to 60/or with 35 years of service. Currently, staff can only retire earlier than 66 with significant financial penalty. In Minnesota, probation/parole staff is the only members of the public safety system without an earlier retirement option. Most of our neighboring states have an earlier retirement option for their probation/parole staff, and most provide an option even earlier than what this bill proposes. For our own health, for the health and effectiveness of the public safety system in our communities, for the benefit of our clients, and for the ability to recruit new staff, we strongly believe the dangerous and caustic nature of this public safety work performed over decades necessitates the option to retire by age 60/or with 35 years of service. We understand that due to the financial realities in our state and communities, this is a self-funded bill. The actuarial work performed for this bill indicates there would be an additional contribution from every probation/parole staff beginning in 2026 to fund this bill and retirement eligibility would start in 2028. Those additional amounts would be 5.47% for PERA members (which would be a total PERA pension contribution of 11.97%) and 5.39 % for MSRS members (which would be a total MSRS pension contribution of 11.39 %). We understand PERA has indicated they would be most comfortable with a bill if the early retirement option would ONLY apply to yet to be hired new probation/parole staff going forward. This is absolutely not okay with all of us who are doing this work now on behalf of our Minnesota communities. We also understand some legislative members of the committee seek more clarity if younger probation/parole staff, who would be paying into this pension improvement longer, are in support of this bill. Be we younger or not as young, all of us probation/parole staff see a great need and value to be able to retire from the nature of this work six years earlier at the age of 60 or with 35 years of service. We probation and parole staff, across all age ranges, respectfully ask you and urge you to support this bill."
