

**2021 Omnibus Pension and Retirement Bill:
SF 1712-Rosen/Nelson, M., 2nd Engrossment,
as passed by the Senate**

Source Bills

- 1. SF950-Pappas; HF407-Nelson, M., and Commission Amendment S1712-3A**
MSRS; Increases the benefit for a former employee of the Department of Labor and Industry to the amount stated in erroneous benefit estimates provided by MSRS.
- 2. SF1303-Pappas; HF1459-Nelson, M.**
St. Paul Teachers Retirement Fund Association; Delays the employee contribution rate increase and corrects an error relating to the discount rates for early retirement benefits.
- 3. SF1452-Frentz; HF1291-Murphy**
Judges Retirement Plan; Reduces the postretirement adjustment and eliminates the triggers that increase the postretirement adjustment upon attainment of specified funding ratios.
- 4. SF1454-Pappas; HF1497-Feist, and Commission Amendment S1712-5A**
Revises coverage requirements for MSRS for employees with H-1b and E-3 visa status to comply with federal law and clarifies the same requirement for PERA.
- 5. SF1712-Rosen; HF1758-Nelson, M., and Commission Amendments H1758-1A and S1712-2A**
PERA 2021 administrative bill.
- 6. SF1925-Abeler; HF2192-Heinrich**
Ramsey Fire Relief Association and Nowthen firefighters; Provides full vesting and distribution of accounts to firefighters assigned to the Nowthen fire station and makes other changes to assist the new Nowthen fire department.
- 7. SF1993-Howe; HF2163-O'Driscoll, and Commission Delete-Everything Amendment S1993-1A**
PERA; Extends the time period for purchasing service credit for periods of federally protected military service leave.
- 8. SF2056-Rosen; HF2145-Nelson, M., and Commission Amendment S1712-8A**
Amends current law as recommended by the State Auditor's fire relief association working group.
- 9. SF2098-Pratt; HF2188-Mortensen**
MSRS Correctional; Transfers one state employee's service credit from the general plan to the correctional plan.

10. SF2252-Howe; HF1107-Murphy

PERA Statewide Volunteer Firefighter Plan; Permits the allocation of fire state aid between the SVF plan and municipalities.

11. SF2405-Rosen; HF2514-O'Driscoll, and Commission Amendment S2405-2A

MSRS Unclassified; temporarily extends the grandfather provision regarding actuarial assumptions used to compute an annuity.

12. SF2485-Bigham, Commission Oral Amendment, and Senate Floor Amendment scs1712a-1

Establishes a working group to consider changes to the pension benefits for 911 telecommunicators.

13. Commission Bill Draft LCPR21-023, and Commission Oral Amendment

Revises the deadline for submitting bill drafting requests to commission staff for agencies and pension systems; oral amendment deleted references to the State Auditor.

14. Commission Amendment S1712-2A

Makes technical clarifications and corrections.

15. Commission Amendment S1712-7A

Establishes a work group to be convened by the State Auditor to consider the allocation of firefighter supplemental state aid.
