1.4 association from 66 to 65; reducing the employee contribution rates for two years
1.5 by 0.25 percent for St. Paul Teachers Retirement Fund Association; extending the
1.6 suspension of earnings limitation for retired teachers who return to teaching;
1.7 authorizing eligible employees of Minnesota State Colleges and Universities who
1.8 are members of the higher education individual retirement account plan to elect
1.9 coverage by the Teachers Retirement Association and purchase past service credit;
1.10 implementing the recommendations of the State Auditor's volunteer firefighter
1.11 working group; adding a defined contribution plan and making other changes to
1.12 the statewide volunteer firefighter plan; modifying requirements for electing to
1.13 participate in the public employees defined contribution plan; increasing the
1.14 multiplier in the benefit formula for prospective service and increasing employee
1.15 and employer contribution rates for the local government correctional service
1.16 retirement plan; eliminating the workers' compensation offset for the Public

2.42 Section 1. Minnesota Statutes 2023 Supplement, section 354.05, subdivision 38, is amended

2.44 Subd. 38. **Normal retirement age.** "Normal retirement age" means age 65 for a person
 2.45 who first became a member of the association or a member of a pension fund listed in section
 2.46 356.30, subdivision 3, before July 1, 1989. Through June 30, ~~2025~~ 2024, for a person who
 2.47 first becomes a member of the association after June 30, 1989, normal retirement age means
 2.48 the higher of age 65 or "retirement age," as defined in United States Code, title 42, section

3.1 416(l), as amended, but not to exceed age 66. Beginning July 1, ~~2025~~ 2024, normal retirement
 3.2 age for all members means age 65.

3.3 **EFFECTIVE DATE.** This section is effective retroactively from July 1, 2023.

4.18 (b) "Executive director" means the executive director of the Teachers Retirement
4.19 Association.

4.20 (c) "Individual retirement account plan" means the individual retirement account plan
4.21 governed by chapter 354B.

4.22 (d) "Maximum past service credit" means service credit for the period beginning with
4.23 the date the eligible person was first covered by the individual retirement account plan to
4.24 the transfer date.

4.25 (e) "Minnesota State" means the Minnesota State Colleges and Universities.

4.26 (f) "Transfer date" means the date selected by the executive director under subdivision
4.27 5 for the purpose of preparing the estimates required by subdivision 5.

4.28 Subd. 2. **Authority to transfer coverage.** Notwithstanding any provision of law to the
4.29 contrary, an eligible person described in subdivision 3 is authorized to become a member
4.30 of the Teachers Retirement Association and purchase service credit upon making an election
4.31 under subdivision 6.

5.1 Subd. 3. Eligible person. (a) An eligible person is a person who:

5.2 (1) is employed by Minnesota State;

5.3 (2) has an account in the individual retirement account plan; and

5.4 (3) satisfies paragraph (b).

5.5 (b) A person satisfies this paragraph if Minnesota State is not able to produce at least

5.16 To elect coverage by the Teachers Retirement Association, an eligible person must submit
5.17 a written application to the chancellor on a form provided by Minnesota State. The application
5.18 must include:

5.19 (1) an attestation that the person was not informed of the right to elect a transfer from
5.20 the individual retirement account plan to the Teachers Retirement Association and the person
5.21 was unaware of the right to elect such a transfer;

5.22 (2) the date on which the person first became a participant in the individual retirement
5.23 account plan;

5.24 (3) a signed release authorizing Minnesota State to provide employment and other
5.25 personnel information to the Teachers Retirement Association; and

5.26 (4) any other information that Minnesota State may require.

5.27 (b) No later than 60 days after receipt of the application under paragraph (a), Minnesota
5.28 State must verify the information provided by the person in the application, determine
5.29 whether the person is an eligible person under subdivision 3, and provide a written response
5.30 to the person regarding the determination of eligibility. If Minnesota State determines that
5.31 the person is not an eligible person, Minnesota State must include a copy of any

6.1 documentation identified in subdivision 3, paragraph (b), in its written response to the
6.2 person.

6.3 (c) If Minnesota State determines that the person is an eligible person under subdivision
6.4 3, Minnesota State must forward to the executive director:

6.8 (3) salary history for the eligible person;

6.9 (4) an estimate of the amount available for transfer from the eligible person's account

6.12 Subd. 5. **Determination of service credit purchase amounts.** (a) Upon receipt of the
6.13 application and information under subdivision 4, the executive director must prepare estimates
6.14 of the following as of a prospective transfer date selected by the executive director that is
6.15 no later than 90 days after receiving the application and information under subdivision 4:

6.16 (1) the purchase payment amount determined under section 356.551 to purchase the
6.17 maximum past service credit;

6.18 (2) the amount of service credit the eligible person would receive if the amount estimated
6.19 under subdivision 4, paragraph (c), clause (4), is transferred to the Teachers Retirement
6.20 Association and used to purchase service credit under section 356.551;

6.21 (3) the purchase payment amount for additional years of service credit, if any, not to
6.22 exceed the maximum past service credit; and

6.23 (4) the offset amount attributable to the eligible person.

6.24 (b) No later than 90 days after receiving the application and information under subdivision
6.25 4, the executive director must send a written communication to the eligible person with the
6.26 amounts determined in paragraph (a) and inform Minnesota State of the offset amount. The
6.27 executive director may charge the eligible person a reasonable fee to cover the costs of
6.28 calculating the amounts required by paragraph (a).

6.29 (c) Minnesota State must notify the eligible person and the executive director no later
6.30 than 30 days after receiving notice of the offset amount from the executive director under
6.31 paragraph (b) if there are sufficient funds in the IRAP to TRA transfer account to pay the

7.3 Subd. 6. Election to transfer coverage and purchase of service credit. (a) No later
7.4 than 60 days after the executive director sends the written communication required by

7.7 date.

7.8 (b) If the eligible person elects to transfer coverage under paragraph (a), the available
7.9 balance in the eligible person's account in the individual retirement account plan must be
7.10 transferred to the Teachers Retirement Association, not to exceed the amount required by
7.11 the Teachers Retirement Association to purchase the maximum past service credit, as
7.12 adjusted for the offset amount, if any.

7.13 (c) If the available balance in the eligible person's account in the individual retirement
7.14 account plan plus the offset amount, if any, is less than the amount needed to cover the cost
7.15 to purchase the maximum past service credit, the eligible person must:

7.16 (1) direct the transfer of funds from the eligible person's account in the higher education
7.17 supplemental retirement plan established under chapter 354C, from a source specified in
7.18 section 356.441, subdivision 1, or from more than one of the foregoing sources in an amount,
7.19 in total, sufficient to cover the rest of the cost to purchase the maximum past service credit;
7.20 or

7.21 (2) elect fewer years or partial years of service credit corresponding to the amount of
7.22 service credit that may be purchased using the funds transferred from the individual
7.23 retirement account plan, the offset amount, and if directed by the eligible person, funds
7.24 from any of the sources described in clause (1).

7.25 (d) Minnesota State must promptly initiate the transfer of funds or work with the eligible
7.26 person to initiate the transfer of funds to the Teachers Retirement Association from the
7.27 eligible person's account in the individual retirement account plan and, if directed by the
7.28 eligible person under paragraph (c), from any other account over which Minnesota State
7.29 has the authority to initiate or approve transfers when directed by a participant.

7.30 (e) Unless the balance in the IRAP to TRA transfer account is zero, Minnesota State
7.31 must direct a transfer to the Teachers Retirement Association of an amount that is equal to
7.32 the offset amount attributable to the eligible person. If the balance in the IRAP to TRA
7.33 transfer account is less than the amount needed to transfer the offset amount, Minnesota

8.1 State must direct a transfer of the remaining balance in the IRAP to TRA transfer account
8.2 to the Teachers Retirement Association.

8.3 Subd. 7. **Commencement of membership in the Teachers Retirement Association.** (a)
8.4 Upon receipt by the Teachers Retirement Association of the transfer or transfers under
8.5 subdivision 6, the eligible person's membership in the Teachers Retirement Association
8.6 commences effective as of the transfer date and the executive director must grant past service
8.7 credit to the eligible person.

8.8 (b) The executive director may adjust the amount of past service credit granted to the
8.9 eligible person as necessary to ensure that the Teachers Retirement Association does not
8.10 receive less than required to cover the cost of the past service credit granted.

8.11 (c) Upon membership commencement, the eligible person ceases to be an active

8.19 service credit to the eligible person for all years or partial years of service with Minnesota
8.20 State for the purpose of vesting in a retirement annuity under section 354.44 or in a retirement
8.21 benefit under section 354.46 or 354.48.

8.22 Subd. 9. **Notice to employees.** No later than March 31, 2025, and periodically thereafter,
8.23 Minnesota State must provide notice to all employees summarizing this section and offer
8.24 assistance to any eligible person who wishes to elect to transfer coverage from the individual
8.25 retirement account plan to the Teachers Retirement Association. Minnesota State must
8.26 designate personnel responsible for assisting employees with the requirements of this section.
8.27 The notice must identify these personnel and provide their contact information.

8.28 Subd. 10. **Annual report required.** The chancellor and the executive director must

10.6 ~~division or account of a partially salaried and partially volunteer firefighters relief association~~
10.7 that is:

10.8 (1) organized and incorporated as a nonprofit corporation to provide retirement benefits
10.9 to volunteer firefighters and paid on-call firefighters under chapter 317A and any laws of
10.10 the state;

10.11 (2) governed by this chapter and sections 424A.091 to 424A.095; and

10.12 (3) directly associated with:

10.13 (i) a fire department established by municipal ordinance;
