Sen. Howe moved approval of the March 25, 2025, meeting minutes. MOTION PREVAILED.

SF 1122 (Frentz); HF 139 (O'Driscoll): PERA Police & Fire; State Patrol; Increasing COLAs; eliminating the waiting period for a COLA for the PERA Police & Fire Plan

Sen. Frentz and Rep. O'Driscoll presented and testified in support of their bill.

Aleena Wilson, Analyst, Legislative Commission on Pensions and Retirement (LCPR), reviewed the staff summary of the bill.

Erin Leonard, Executive Director, Minnesota State Retirement System (MSRS), testified that the MSRS board is generally supportive of benefit improvements as long as they are funded.

Doug Anderson, Executive Director, Public Employees Retirement Association (PERA), testified that the board supports the bill, contingent upon full funding of the cost.

Mike LeDoux, President, Minnesota State Patrol Troopers Association (MSPTA), testified in support of the bill and provided two handouts: <u>Handout 1</u> (Highlighted LCPR principles) and <u>Handout 2</u> (COLA study presentation).

Rep. Hill moved LCPR25-031 be recommended to pass and be incorporated into the 2025 omnibus pension bill. **MOTION PREVAILED**.

Report of the Amortization Work Group

Susan Lenczewski, Executive Director, LCPR, reviewed the bill and amendments.

Doug Anderson, testified in support of the bill on behalf of the Amortization Work Group (<u>Amortization</u> <u>Work Group Presentation</u>), and as Executive Director on the PERA Board position in support of the bill.

Tim Maurer, Executive Director, TRA (<u>Layered Amortization Considerations for TRA</u>), testified that the TRA board supports layered amortization, but amortized over 20 years instead of 15 years, and the LCPR25-009-1A Amendment achieves that.

Erin Leonard, Executive Director, MSRS, testified that the MSRS board is in support of the bill.

Phill Tencick, Executive Director/CIO, St. Paul Teachers, testified that the SPTRFA Board supports layered amortization and uniformity across plans.

- Sen. Rasmusson moved LCPR25-009 be recommended to pass and be incorporated into the 2025 omnibus pension bill. MOTION PREVAILED.
- Sen. Westlin moved the First Amendment to the Commission Standards for Actuarial Work.
 MOTION PREVAILED.

<u>Bill Draft LCPR25- 030</u>: Firefighter Relief Associations; Repealing the Investment Business Recipient Disclosure annual reporting requirement

Susan Lenczewski, Executive Director, LCPR, reviewed the staff summary of the bill.

State Auditor Julie Blaha testified in support of the bill.

Rose Hennessy-Allen Pension Director, State Auditor Office, testified that the OSA already receives detailed investment data; just not the specific names of the banks, but that is filed with the Campaign Finance and Disclosure Board.
